



The Government has failed to respond to our Official King Sealed Documents and Public Notice Letters which I e mail UK Officials illegal War Powers Act abuse against us when there is No War here but a Serious Threat of NZ Government Forcing 29 Legislation Acts through Parliament through December January and February hoping to Enforce them Illegally to subject us to another emergency Lockdown Disruption of our Lives takeover through Political Tampering of UK Courts "Reciprocal Enforcement of Judgments Act 1934" Laws through Legislations to lock us up indoors while they will soon use UN Military to overpower us the Original NZ Natives Born on these Lands and take over our country with our own Entrenched British 1835 King William IV Federal Constitution Contract Flag they are flying in NZ Government Buildings as a Counterfeit "Whakaputanga Flag" because they have no legal Inheritance Inherent Jurisdiction Flag links to Britain!
