There is a Private Commercial Contract Agreement "Moai Crown King William IV Trust" Commonwealth N.W.O Senate Committee based on Moai Uetaha Wa Noa Rai'atea Island Royal Tahitian Family Ancestral Inheritance Lands at Te Pito, Moko'Nui Urupa Memorials, Marangairoa Marae East Cape North Island New Zealand direct to Te Pito, Rapa'Nui Urupa, Moai Statue Memorials at Anakena, Easter Island. Direct to Devon (Port) England King William IV Ancestral Inheritance Stone Memorial Land of his Successors King Ernest Augustus V aged 66 King of Britain UK, Hanover and Moai Pacific Islands Commonwealth World. He is succeed to his son Prince Regent Ernest Augustus 33 who we envisage as the King of Britain UK Successor immediately of the opening of the Upper

Off the record book she is holding in her hands about Ngati Hine Hapu as being beholding to Nga Puhi Chiefs DOI Flag origins of the Confederation. Hohepa Epiha better acknowledges the 1835 Declaration of Independence Flag Authority from under the Pohutukawa tree at Te Ngaer over the hill from Matauri Bay where Busby made this Flag of King William IV History. The Geographic Maps had meetings with the Department of Conservation DOC. To include the Flag and meeting of all Chiefs under this Tree on the river side by the sea where all the waka (Canoe) came in and stayed in the paddock here marked in History of Aotearoa Beginning of Pakeha settlements in the area of Bay of Islands in a signed agreement between Busby for British UK Government and Moai Hapu Native Chiefs. There wasn't Maori (Pakeha Iwi Tribe invented) at that time 1835 to 1945 but Moai Native Tahitian People

Taumata Kaumatua Hohepa Epiha will make the official trademark of Nga Puhi "Haumea Hueae Tahiki E" to signal approval from the other Taumata Assembled in Congress to raise the Moai Hapu Sovereign Chiefs DOI Flag on the Navy Ship of Admiralty Flag Pole opposite the NZ Government Treaty Grounds Marae what was just spoken about and agreed to and that it would take 12 months to deal with issues, starts with TPPA, Global Warming, Raising the Confederation Flag, the Maori Land Cour, Sacking John Key Government.

Please note for the Taumata in Congress record that the Rangatira and Arataki gave their Taumata Kaumatua Elder from their Marae in one of the 4 Regions Laws of their Hapu and their Business Development Plans, including Environmental issues, Governing Structures and other Policy matters for Congress Native Government approval for over the next 12 month period to 6/2/2017 for representation or amendments to their Native Laws. The Hapu Taumata in their Regions share their new Information with Congress Native Council of 12 members to redistribute to other Taumata throughout the Motu (Country) The main purpose of an Upper House shall Veto any Political Decisions such as TPPA threat against 'Moai Crown King William IV Trust' Commonwealth of the New World Government Financial Investment Interests and that of Maori Hapu and Taumata Land Ownership Kaitiaki Administrator National Sovereignty T.M Priorities.

Now the Rangatira can now take their Laws and Business Plans to their Hapu to enforce their own Authority over their own Lands. It means then Consent to the Native and those

Who affiliate from the public non Natives can now exercise their rights for the very first time in 181 years. The Taumata Kaumatua of Ngapuhi and the rest of the Taumata Arataki and Rangatira from the Native Council of Hapu from around the Country, can now stop any alienation of their lands and investigate every Title of those lands as in our case "Moai Crown" Federal State Sheriffs will enforce their Laws over their Ancestral lands and in the case of Moai Hapu Native Titles are now the Sovereignty Monarch Memorial Lands of

the Doctrines of Discovery Titles that have been hidden by John Key New Zealand NSW Colonial Government without a Queen or a King Sovereignty Jurisdiction as against Moai King William IV Memorial Titles of Commercial Banking Money Inheritance that only the legitimate name surname appears on their British UK Westminster Land Laws of England Registrar of Founding Doctrines Deeds from Glasgow Real Estate Company in Scotland, the "MANUKAU LAND COMPANY" This is all that was required to satisfy Britain
