



With the act, the President was allowed to censor mail and other forms of communication between the United States and foreign countries. The act and all changes created by its power were to remain intact until six months after the end of the war at which time, the act would become defunct.

Three months after passing the first, the **Second War Powers Act** was passed on March 27, 1942.[2] This further strengthened the executive branch powers towards executing World War II. This act allowed the acquisition, under condemnation if necessary, of land for military or naval purposes. Some provisions of the Hatch Act of 1939 were also suspended which reduced naturalization standards for aliens within the U.S. Armed Forces. In addition, it created methods for war-related production contracting along with adjusting several other aspects of government affairs.[1] The Second War Powers Act repealed the confidentiality of census data, allowing the FBI to use this information to round up Japanese-Americans.[3]

Under Secretary of War Robert P. Patterson retroactively delegated his authority from the President under the War Powers Act of 1941 to Leslie Groves for the Manhattan Project. The authority, given in a memorandum to Groves dated April 17, 1944, was retroactive to September 1, 1942. The written delegation was only given in 1944 when Grove's deputy Kenneth Nichols was about to sign a large contract with Du Pont, and it was found that he only had a low delegated authority, as Nichols' higher authority for the Manhattan Project had only been given verbally by General Styer to his predecessor Colonel James C. Marshall.[4]





Ask Sir Hugh to explain himself to you and to myself Mohi Manukau how he came to be in occupation at Bastion Point Ask him to produce for your record his PROOF OF TITLE to all land he is sitting on and the land he now wishes to settle with the Crown on whose behalf and who in the Tribe supports him and how many are registered with the Ngati Whatua O Orakei Trust Board to give his mandated Claims to the Crown

If he fails to produce this evidence to you OTS and to our Legal Counsel and myself before the close off date Monday 31st July 2006 then we will accept his SILENCE or non written statement of response as a relinquishment of his collective or individual Tile Claim to the Ngati Whatua lands to myself the Rangatira of the greater Ngati Wha Atua [Ngati WhatuaTribe] their collective Hapu and tribal affiliations

We will not be separated from our Hapu Tribal Links nor accept the Crowns lesser than settlement or redress

We present our CLAIM direct to the CROWN for the return of all Lands taken by the Crown for it's purpose Land which belonged to the Hapu of Ngati Wha Atna [Ngati Whatua] Tribe We now claim by way of 100% ACCEPTED FOR VALUE as equitable COMPENSATION incurred for all losses Land Resources Treasures

We ask the CROWN to produce WRITTEN PROOF OF TITLE for their Claims to Legal Valid Title Ownership to all of our Lands and if not then we will ask the Crown to relinquish their Paper Titles to us We can present this to OFFICE OF THE TREATY SETTLEMENTS Please take note of statements we make here

We do not support Ngati Whatna O Orakei Maori Trust Board Inc and their Hapu isolating themselves from originations of NGATI WHA ATUA [Ngati Whatna] TRIBE a discouragement for future Maori generations

We don't support their claim rights to represent individual Hapu outside their area of jurisdiction to conduct Crown Negotiations on behalf of the original and greater Auckland Hapu and Tribes such as ours Ngati Whatua roots are formally established with our tribes here in Helensville The Crown needs to talk to us now about our claims and our Proof of Title Ownership These Titles are substantial in their entirety

We are asking you and OTS to wait for a formal response to our letter from Sir Hugh Kawharu the Chairman of Ngati Whatua O Orakei Trust Board Inc He may not respond to a letter from myself to him because his MANA would become questionable then tenable putting his position in jeopardy in front of his Hapu and Whanau When I speak on his Marae he disappears out of sight in case I question him about this

We express our full legal authority to challenge your Titles Please present your proof of Title in writing to this urgent Notice copies of which are sent to you at Office of Treaty Settlements Rodney District Council, Paramount Leaders of other Tribes The Maori Party, The Ratana Church, The UN Special Rappprtuer Rodoflo Stavenhagen, Local Hapu, and the World Media


