

The LANDOWNERS JAMES BROWN and SIMON ROUNDTREE and or any BANKS who have TITLE MORTGAGED this LAND have done so knowing that we had a LEGAL INTEREST in the LAND TITLE SOIL by our ORGANIC TITLES which OVERRIDE NGATI WHATUA O ORAKEI IWI “CROWN” LAND TITLES. These OWNERS will have no right to enter into this Contract “MOAI CROWN” has with Douglas RIKARD-BELL and his TITLES before he SOLD this Land FRAUDULENTLY to SIMON and JAMES since the Police are already convicted as Accessories to this FRAUD Committed now cannot re enter into our CONTRACT. Our Private Investigator Aylett Investigations is assisting us in recovering and salvaging the ACCUSED VESEL IN PERSONAM Debt from each ACCUSED PERSON and the LAND PROPERTY they FORFEIT because of LACK or RESPONSE in our MOAI CROWN COURT!
