**NATIONAL CONFEDERATION OF CHIEFS HAPU TRIBES TAUMATA IN CONGRESS ASSEMBLED “AGREEMENT”**

By signing this Agreement, the Assembled Chiefs Taumata Kaumatua Elders hold the Land Sovereign Legal Authority of Jurisdiction over, above, below and within this land of our Native Tahitian Pacific Moai Forbearer’s, let the first man challenge his Alien Land Title here today in front of the Organic Native Indigenous Moai Earth God Sovereign Spirit Lore Hapu Chiefs Taumata Congress Assembled with the surrogate King William IV Admiralty Court Martial Law ‘1835 Declaration of an Independent Sovereign Nation State Flag’ of Jurisdiction, so help us God, the founding fathers ask you to bless the opening of this Upper House of Parliament today an International

Moai/Maori and Pacific Islands Approved Trade Investment Banking, Land, Air, Sea Co Operative Self Government New World Order Business. The Taumata 4 Regions Collective Congress Assembled agree, that on signing this Contract, shall proceed immediately to Seize back into its Custody the lands of the Treaty of Waitangi Grounds and the King William IV Ship of Admiralty Court Flag Pole bearing his Moai Hapu 1835 Declaration of Independence Sovereign Nation State Country Flag Legal Authority Jurisdiction, Enforce the Moai/Maori Native Self Government Law Congress Approved Passed into Law to raise the 1835 Hapu Sovereignty Flag from cross Bar to the position at the Top of the Pole where the NZ Union Jack Flag drops down into its position on the cross Bar opposite the UK

The Total number of National Taumata in Congress Assembled, unanimously passed New Laws in the 'Upper House' virtually limiting the 'Lower House' of Parliament Authority to Govern New Zealand Country exclusively from Wellington. **Prime Minister John Key NZ Government, Governor General** is sacked by **12 Elected Taumata Sovereign Authority Confederation Chiefs in Congress** on the 6<sup>th</sup> February 2016. Or the Ruling Authority Native Government may choose to let John Key continue to Govern with Restrictions.

**Please note;** This Agreement should be treated as Authentic Legal Statements of Natives Hapu Founding Doctrines of Title Documents

**Affidavit; Taumata** (Native Elder s) and their **Arataki** (Legal Lore/Law Scribe) sign as one Nation 4 Region Taumata Confederation and as separated Parliaments Republics of their own 4 Regions. Those who sign agree in Congress Assembled to abide by International Laws attached to their own Local Regions Laws in their own Separate Law Enforcement States/Republics Regions as only membership

**The Confederation** shall meet in Congress on the 28<sup>th</sup> October of each year Declaration of Independence Day **181 years** this **2016** year to bring their Laws and Development Project for funding, into the main Upper House of Parliament for the Taumata to Adjudicate on. They then go away and return on 4<sup>th</sup> 5<sup>th</sup> 6<sup>th</sup> February to have their Laws, passed by the **Taumata** and their Native **elected Government re-elected** on the 5<sup>th</sup> February every year, or longer if the **Taumata agrees**. The Taumata is not the Government and vice versa applies.

For those who do not wish to adopt this method of Authority, then you would not have to take part in it and will have to wait for the next 12 month period or longer if the Majority of Taumata agrees it is worth the effort to apply use it as a written Agreement at Law.
