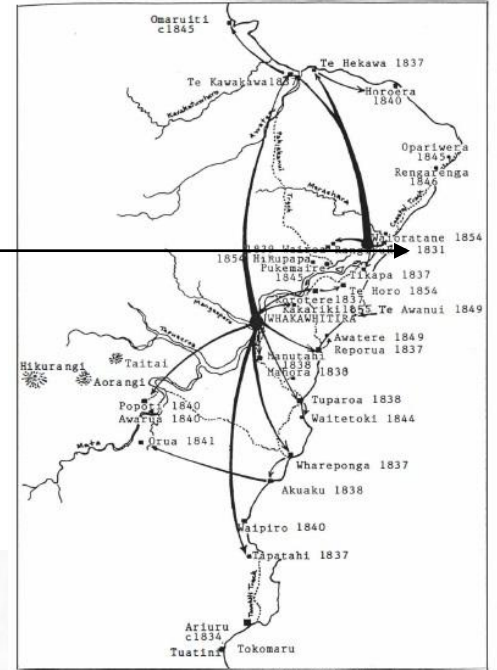

James. R. Clendon was a British citizen and bus official position of Consul of the United States. He reported, to Washington D.C., any significant political developments related to New Zealand. According to Ian Wards, N.Z. Government Historian (1946-1968) and Chief Historian (1968-1983), a number of individuals were instrumental in creating the final English draft wording of The Treaty of Waitangi on the 3rd-4th of February 1840. Their combined efforts resulted in the final English draft document, which was handed to Rev. Henry Williams at 4pm on the 4th of February, for translation into the Maori language. The "Treaty" writing/ advising participants were, including those named by Wards: William Hobson (Lieutenant Governor), James Busby (British Resident), J.S. Freeman (Hobson's personal secretary), J.R. Clendon (US Consul), H. Williams, (Head missionary) and A. Brown (missionary).

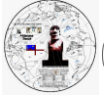
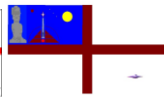

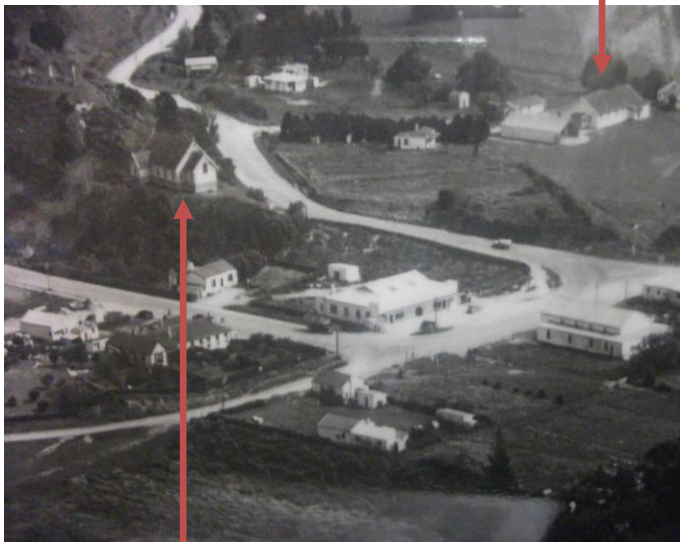

It appears that no consideration has been given to watermarks, when tracing pedigrees of the draft notes of the treaty. By comparative analysis we can ascertain who owned a particular brand of paper and trace the movements of draft writers back to the locations where they kept their paper stocks.



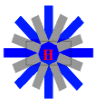
Even on microfilm copies of Clendon's Consular despatches, the W. Tucker 1833 watermark is clearly discernible. The top half of the above, two-part picture shows the faint outline of the W Tucker 1833 watermark. The bottom half indicates how it sits and appears on the same page. Clendon is the only individual in New Zealand known to be using this unique paper stock in February 1840, which points conclusively to him being the owner of the paper upon which the Littlewood Treaty was written. This watermark evidence further supports historian Ian Wards' statement that Clendon was present when the English draft wording was worked out. Busby, quite obviously, penned it at Clendon's premises, where Clendon kept his personal supply of paper. It seems unlikely that Clendon would have carried the paper to another venue. Either way, it was his paper stock.

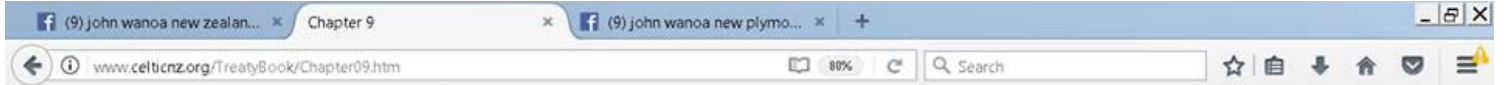
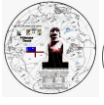
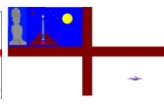

(see Clendon MSS, taken from Professor Rutherford's copy, Clendon House Papers, Special Collections, Auckland Public Library... original now missing). Hobson, very early on, was enamoured by the general location where Clendon lived, as it soon became the seat of government for New Zealand. We know that all buildings or lands acquired by Hobson in March and April, on behalf of the government, belonged to Clendon. These included those for his own family, other incoming staff or soldiers, government store facilities and, ultimately, the physical premises of the first Government House of New Zealand.

When Hobson wrote to Lord Stanley from the new Government House in Auckland on August the 4th 1841, he acknowledged that the government owed James Reddy Clendon 18-months rental. This tells us that government rental of at least some, and later all, of Clendon's premises commenced in February 1840. Hobson states:

'His Excellency replied that he saw no objection to my paying a fair rent for the stores and premises, which have been for the last 18 months of the highest value to the Government'.

'...and I submitted to the Executive Council the propriety of granting, at the usual rate of interest in this country, a sum of money amounting to two thousand three hundred pounds (2,300) as rent for the 18 months for the stores [large storage sheds] wharves, dwelling houses and other premises that had been used in the Government service at Russell, and to give Mr. Clendon a maximum grant of land according to the provision of Act of Council 4 Vict. No. 7 in compensation for the land, buildings &c. at that place...' (see The Auckland Chronicle, "Extracts From The Latest Blue Book", Despatch no. 41, Governor Hobson to Lord Stanley, The Clendon House Papers, Special Collections, Auckland Public Library).

Clendon appears to have first met Hobson in 1837 when Hobson had to intervene, with the help of missionary Samuel Marsden and James Busby, to negotiate, in behalf of the settlers, during hostilities that had broken out between Pomare II and Titore. During the fighting two great chiefs, Pi and Titore were killed and it was feared that their deaths would inebriate "utu" or revenge killing. At that time, when Captain Hobson arrived in H.M.S. Rattlesnake in a show of British naval strength and gunboat diplomacy, the English settlers risked being caught in the middle of the warring Maori factions. Clendon's Okato estate was purchased from Pomare II and Kowhiri of Ngau Mamu in 1830 and Pomare's PA was situated adjacent to the 10-acre of land that Clendon had bought in 1836. Clendon made further purchases from the chief in 1837 (80 additional acres at Okato) and 1838 (The Clendon farm of 3,342 acres at Manawaora).

'Early in 1837 the British Resident in New Zealand, James Busby, sent word that tribal war was endangering British subjects. Hobson left in the Rattlesnake, arriving at the Bay of Islands on 26 May. He met Busby; spoke with missionaries, prominent settlers and Maori leaders. With Samuel Marsden and Busby he interviewed the warring chiefs, Pomare II and Titore, attempting to reconcile them, and warned against violence to British subjects' (see Dictionary of New Zealand Biography).

From the foregoing information that exists within our historic documents on public file, it can be established that Hobson's movements for February 3rd 1840 put him in reasonably close proximity to property owned by James Reddy Clendon. It is also very probable that Hobson, in 1837, had already met Clendon who, as a close friend of Pomare II, would logically have been one of the prominent settlers aiding Hobson in negotiations with the warring chiefs. From the moment Hobson first landed on the 30th of January 1840, James Reddy Clendon appears to have befriended him and been central to all of his on-shore activities and political incentives.

Inasmuch as Dr. Phil Parkinson has concluded that the Littlewood Treaty was written by James Busby, and in consideration of the fact that the paper upon which it is written came from Clendon's personal stock, we can confidently accept that the date of 4th February 1840, as written upon the Littlewood Treaty document, is correct.

It is very doubtful that Clendon would have carried his personal stock of W. Tucker 1833 paper to a venue outside of his own estate. The compelling evidence shows that the final drafting session was held at his home on the 4th of February 1840 and that at least two copies of the final draft were completed there on that date, including Clendon's own transcribed copy.

Hobson needed to go ashore from the clamour, bustle and confinement of H.M.S. Herald, if for no other reason than to get away from Captain Nias. From the moment HMS Herald had dropped anchor in Kororaraka Bay on the 29th of January, the ship became a hostile environment, where Hobson had no assurances whatsoever, of any cooperation from a belligerent Captain Nias. Tahiti and New Caledonia in the Pacific, since this period, tends to confirm the accuracy of the above rumour.*

Another curious circumstance revived uneasiness on this subject. On the 10th March 1840, a highly favourable despatch was received from Colonel Wakefield. This drew public attention to some papers relating to Captain Hobson's appointment, already laid before parliament; and several influential London merchants were surprised to find the ministers had not ordered that officer to proclaim her Majesty's sovereignty over New Zealand. Without delay, one hundred and fifteen bankers, merchants, and traders of London called a public meeting at Guildhall on the 15th April 1840, to consider the subject, and from this assembly petitions were sent to both Houses of Parliament, praying them to annex the New Zealand islands, "the Britain of the South," to her Majesty's dominions. This led to the appointment of a select committee of the House of Commons to collect evidence on the question, and it was then ascertained that Captain Cook took possession of the islands in the name of King George III., in 1769, and that when New South Wales was declared a portion of the British dominions in 1787, these islands, although not named, were within the proclaimed boundaries as much as Norfolk Island; but that certain acts had occurred since these events which prevented the Queen of England assuming the sovereignty; these were King William IV. having addressed the New Zealanders as an independent people in 1833, and having recognised their national flag in 1834.†

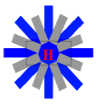

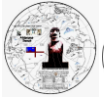
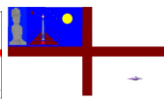

Over the years, New Zealand historians have written voluminously about the New Zealand Company's first organised settlements at Port Nicholson, New Plymouth, Nelson, and elsewhere. Auckland's first organised settlement at Cornwallis beside the Manukau, on the other hand, has never been much more than a mere unregarded footnote attached to our nation's story. Understandably so, perhaps. It never amounted to much. This small community of Scots perched on the rugged, heavily bushed shoreline near Puponga Point, which juts out from the north shore of the Manukau harbour, seemed doomed from the outset, certainly from the moment that Governor Hobson decided some time during 1840 to place his capital on the northern side of the isthmus. The new capital which he created quickly became the port of entry to northern New Zealand. It was unthinkable that the shallow Manukau harbour with its treacherous sandbars could ever have been a serious rival to the Waitemata. But that was far less obvious in the later 1830s than it is to us today. We have to remember that, at that time, most of the Maori people in the region that we now call Auckland lived beside the Manukau. It seemed feasible, therefore, that the shore of the Manukau harbour could also provide the site of an organised white township. This was the hope, anyway, of the New Zealand and Manukau Land Company sponsored in Edinburgh in 1838 by a group of Scottish landed gentry.⁷¹

The Manukau Company developed as an offshoot of the much better known New Zealand Company. Even when it had a completely separate existence, the Manukau Company showed residual signs of the shared origin of these two colonising bodies. Each aimed to build up a substantial emigration fund from the sale of shares or land; each sold land orders whose 'sections' comprised a holding in the country and one town lot; each required, from those who were to be provided with free or assisted passages, evidence of good character and industrious habits.⁷²

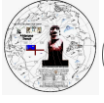
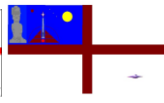
The unusual origins of the Manukau scheme are to be found in a book generally regarded as the first historical survey of early New Zealand, A. S. Thomson's *The Story of New Zealand*.⁷³ Published in 1859, this book provided what Thomson claimed to be 'the secret history of this abortive Manukau settlement'. He maintained that his version was based on information provided by an unnamed settler, a 'gentleman' who (according to the author)

From Tamaki-makau-rau to Auckland

Over the years, New Zealand historians have written voluminously about the New Zealand Company's first organised settlements at Port Nicholson, New Plymouth, Nelson, and elsewhere. Auckland's first organised settlement at Cornwallis beside the Manukau, on the other hand, has never been much more than a mere unregarded footnote attached to our nation's story. Understandably so, perhaps. It never amounted to much. This small community of Scots perched on the rugged, heavily bushed shoreline near Puponga Point, which juts out from the north shore of the Manukau harbour, seemed doomed from the outset, certainly from the moment that Governor Hobson decided some time during 1840 to place his capital on the northern side of the isthmus. The new capital which he created quickly became the port of entry to northern New Zealand. It was unthinkable that the shallow Manukau harbour with its treacherous sandbars could ever have been a serious rival to the Waitemata. But that was far less obvious in the later 1830s than it is to us today. We have to remember that, at that time, most of the Maori people in the region that we now call Auckland lived beside the Manukau. It seemed feasible, therefore, that the shore of the Manukau harbour could also provide the site of an organised white township. This was the hope, anyway, of the New Zealand and Manukau Land Company sponsored in Edinburgh in 1838 by a group of Scottish landed gentry.⁷¹

The Manukau Company developed as an offshoot of the much better known New Zealand Company. Even when it had a completely separate existence, the Manukau Company showed residual signs of the shared origin of these two colonising bodies. Each aimed to build up a substantial emigration fund from the sale of shares or land; each sold land orders whose 'sections' comprised a holding in the country and one town lot; each required, from those who were to be provided with free or assisted passages, evidence of good character and industrious habits.⁷²

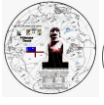
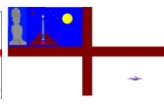
The unusual origins of the Manukau scheme are to be found in a book generally regarded as the first historical survey of early New Zealand, A. S. Thomson's *The Story of New Zealand*.⁷³ Published in 1859, this book provided what Thomson claimed to be 'the secret history of this abortive Manukau settlement'. He maintained that his version was based on information provided by an unnamed settler, a 'gentleman' who (according to the author)

For Europeans the west coast provided industry in lumber and sawmills. It was found to be an agreeable site for settlement. The first European settler, Thomas Mitchell who was a timber merchant from Sydney, arrived in Manukau Harbour in 1834 and settled near Puponga Point. He entered into negotiations with Chiefs Te Kawau, Kawae and Te Tinana; all three of the Ngati Whatua tribe. On the 11th January, 1836 with the assistance of the Methodist missionary, William White, Thomas Mitchell purchased fifty thousand acres in the area with the right to cut timber. He secured this purchase by Apihai Te Kawau, Kauwae and Tinana Ta Tamaki placing their mark on a deed of sale for "a certain portion of Land on the North side of the before named River Manukau, bounded on the West by the sea; on the East by a Boundaries line running North East, from a portion of land known by the name of Otahuhu until it reaches the River Wai te Mata up to its head or source, and from the head of the Wai te Mata, to run a line due West, until it reaches the sea; and on the front and South by the before named River Manukau,"⁵⁴⁹ which translates to the "whole of the Tamaki isthmus between the Manukau and Tamaki rivers on the south and the Waitemata river on the north and from the Tasman sea to the Hauraki Gulf."⁵⁵⁰ The price for this transaction was one thousand pounds of tobacco, one hundred dozen pipes and six muskets. Mitchell built his house and sawmill, reputedly the first in New Zealand, near Mill Bay to process the kauri trees in the area. He planned to sell the lumber in Australia but the operation was not successful. Mitchell drowned shortly after his family joined him, so his wife sold the title to the land holdings for five hundred pounds on the 3rd November, 1838 to a group of mostly Scottish business men. Mrs. Mitchell and her children then returned to Sydney. The entrepreneurs formed a corporation called the New Zealand Manukau and Waitemata Land Company with Captain William Cornwallis Symonds as Agent.⁵⁵¹ This was to be the first fully organized European settlement in the Manukau area. Here it was intended to found a new town as the future for the Auckland isthmus.

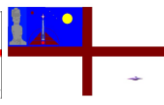

Several observations can be made about the ambit of permissible claims to the Tribunal. First, the focus on Crown practices, policies, acts and omissions reflects the historical fact that the Treaty was entered into by Maori and the British Crown, with the intention of establishing an ongoing relationship between them. Second, that Parliament has allowed Maori to make claims relating to laws is a highly unusual in-road into parliamentary sovereignty, and underscores the Treaty's status as the founding document of the modern nation state of New Zealand. As the Tribunal stated in its report on the Kaituna River claim in 1984:

This is a remarkable result. From being a 'simple nullity' the Treaty of Waitangi has become a document of importance approaching the status of a constitutional document so far as Maoris are concerned. It is not truly a constitutional instrument because conflict between an Act of Parliament or Regulation and the Treaty does not render the statute null and void. But it does expose the Crown to the risk of a claim that the statute in question is in conflict with the Treaty and to that extent it would seem prudent for those responsible for legislation to recognise the danger inherent in drafting statutes or regulations without measuring such instruments against the principles in the Treaty.³⁰

Third, the Tribunal is able to inquire into matters that in most cases are non-justiciable before the ordinary courts. The main reason for this is that claims are founded on a document – the Treaty of Waitangi – that has the status of an international treaty, which the courts cannot enforce unless it is specifically incor-



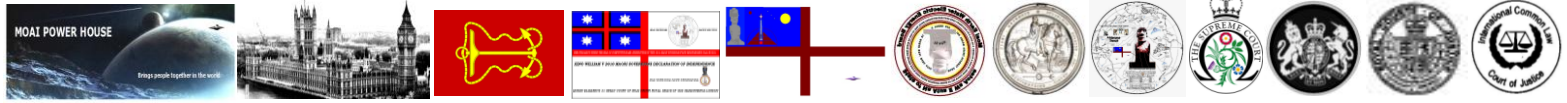

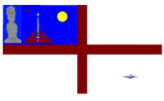
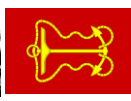


This is a sketch of the original design chosen by a gathering of Māori chiefs at Waitangi on 20 March 1834 to be New Zealand's flag. It was actually one used by the Church Missionary Society, but it is known as the United Tribes' flag after this group of chiefs. The flag contained a red St George's cross on a white background, with a smaller St George's cross bordered with black on a blue background in the upper quarter. A white eight-pointed star was located in each quarter of the smaller cross. Slightly different versions of this flag were subsequently (and mistakenly) used, but this is the original United Tribes' flag. It was replaced as New Zealand's flag by the Union Jack when the Treaty of Waitangi was signed in 1840.

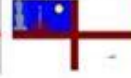
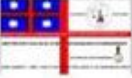

1.8 Barney Dewes came into the Lottin Point area in 1949 from Waipiro. He has noted that when he first went to Lottin Point he did not know about tapu wairua: "As time went on and I found my first skull, I learnt a lot of things." Barney Dewes has experienced personal tragedy in relation to wahi tapu and shown they have affected family members. Eventually, to enable him to use his land, Barney Dewes brought in a tohunga to pinpoint all the sacred places.

1.9 Claimants have noted that others have not been so careful to observe tikanga and the right practice. It is reported that during the building of the Lottin Point Motel, the pakeha owners concreted over a burial site there and built the motel on top.

1.10 The recording of archaeological sites in such density in the Lottin Point and Matakaoa district has led to unexpected results for local Maori land owners. The recorded sites feature as part of the Gisborne District Council's Heritage Protection Plan. Claimants report that the Council has adopted archaeological site recording without consultation with local people. This has led to some odd results as is illustrated by Matekino Smith, the owner-occupier of Wharekahika A8 who, when seeking to have a house established on her land, was informed by the Council that she could not do so as there was a significant site on her land and Council practice was to not allow building within 50 metres of recorded sites. The recorded site was actually a kumara pit not regarded by local people as wahi tapu. Matekino was required to go to her kaumatua with a request that he inform the Council of this fact. Although the matter was resolved, and the house site was confirmed, for Matekino, this experience was wrong, where an outside agency such as the Council assumed the role of protecting cultural sites in a way that called tangata whenua landowners - the kaitiaki of these sites - into account.

But even George Bush will not bring any gold to his grave. Even his Carlyle Group cannot help him in that. They are just finding that out in their own Korambank/Citibank Seoul where they cannot unearth the 1,856MT booked under LSM-666. I have the Deed of Assignment a proof of ownership.
