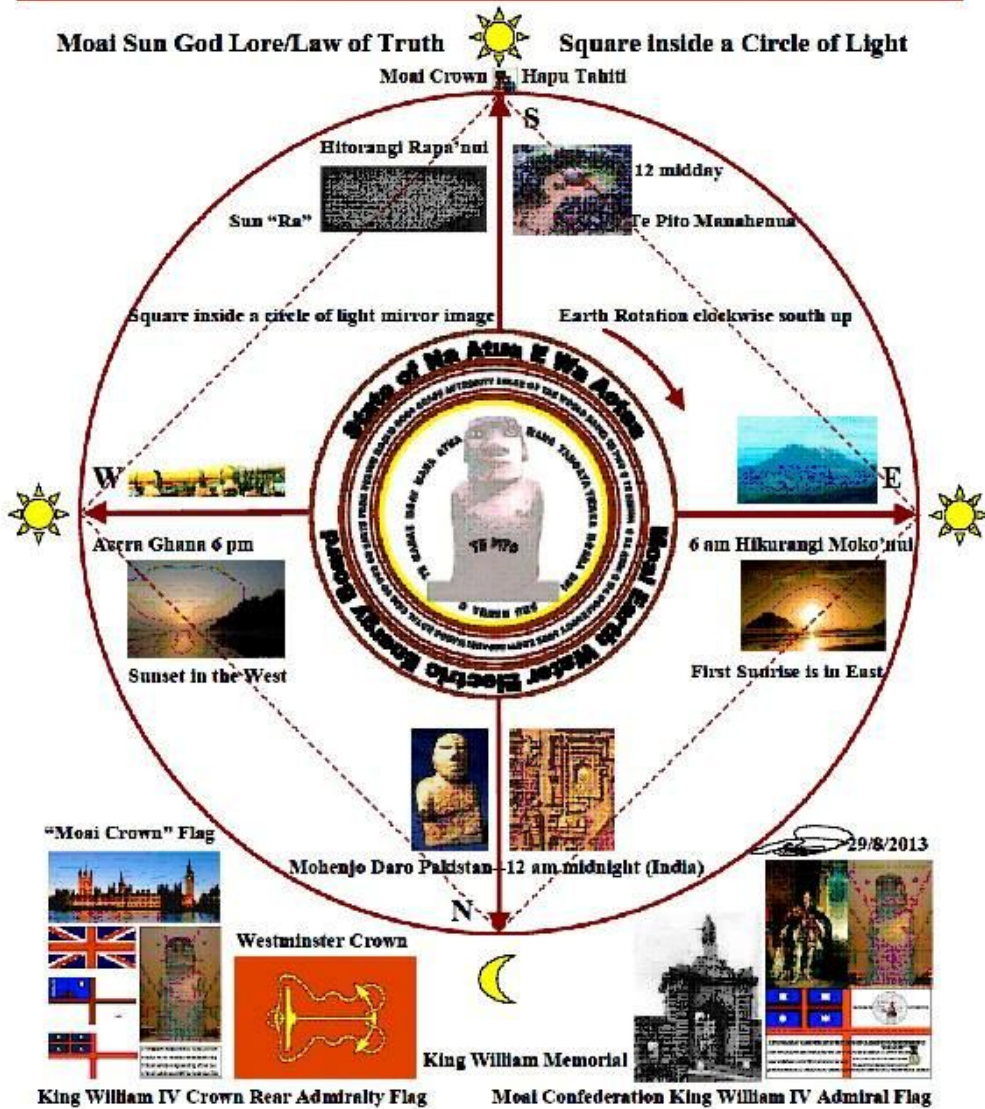

1. "Instant Court" of Admiralty Jurisdiction is under US Const. Art. 3, Sec.. 2.

2. "Prize Phase" of Admiralty Jurisdiction is under the WAR POWERS ACT, Art 1, Sec 8, Clause 11. Law of Prize is a military venue and, when they do a "capture", it is done under the WPA, Art. 1, Sec. 8, Clause 11. A "Seizure" under the civilian venue is done under the US Const., Art. 3, Sec. 2.

3. All is being orchestrated by the Lord High Admiral, the President of the US.

4. All or your judges on the bench today are commissioned vice admirals under the King's Bench.

5. The IRS Code 9.17 states "All assets or seizures are done under the Supplementary Rules, A B C D F G, under the Insurrection and Rebellion Act passed, the first of two Acts was passed 8/6/1861; the second was passed 7/17/1862. See Vol. 12 of the US Statutes-at-Large. Maritime Law has two distinct forms: The Emergency Bank Act was passed by Roosevelt March 9, 1933, aka War Powers Act, and Section 2 amended the Trading With The Enemy Act, originally passed 10/6/1917 to include domestic transactions and made citizens of the US Enemies. Section 5b in the original Act excluded domestic transactions and citizens of the US. § "Constitution of no Authority" by Lysander Schooner. There is an unlimited grant of power HJR 192, (June 5, 1933), The Emergency Banking Act, which was codified into Title 31, section 5118 (2)(d). It is hereby declared to be against public policy for any contract or obligation to contain a clause which purports to give the obligee the right to demand payment in any kind of specific coin or currency of the US. In 1977, it was amended to allow gold and silver coins, but they are still not legal tender.

They are still not using money as legal tender. FRN are not money; they are private bills of credit aka bills of exchange. Under the UNCOTIL United Nations Commission On Trade and International Law, they superseded Article 3 of the UCC in December 5, 1988 in New York City. It is no good anymore under this convention. They have an International UCC and it tells you how to do these bills of exchange. There are 96 articles in this convention, and it tells you how to do the International Bill of Exchange. International Bill of Exchange Bank checks are International bills of exchange.

The United Nations Treaty is the Supreme Law of the Land, not the Constitution. 72 judges and commissioners, called the National Conference of Commissioners, put the UCC together in 1940. They did it from the NIL196 Negotiable Instruments Law 196, which comes from the English Bill of Exchange Act of 1691 and 1692.

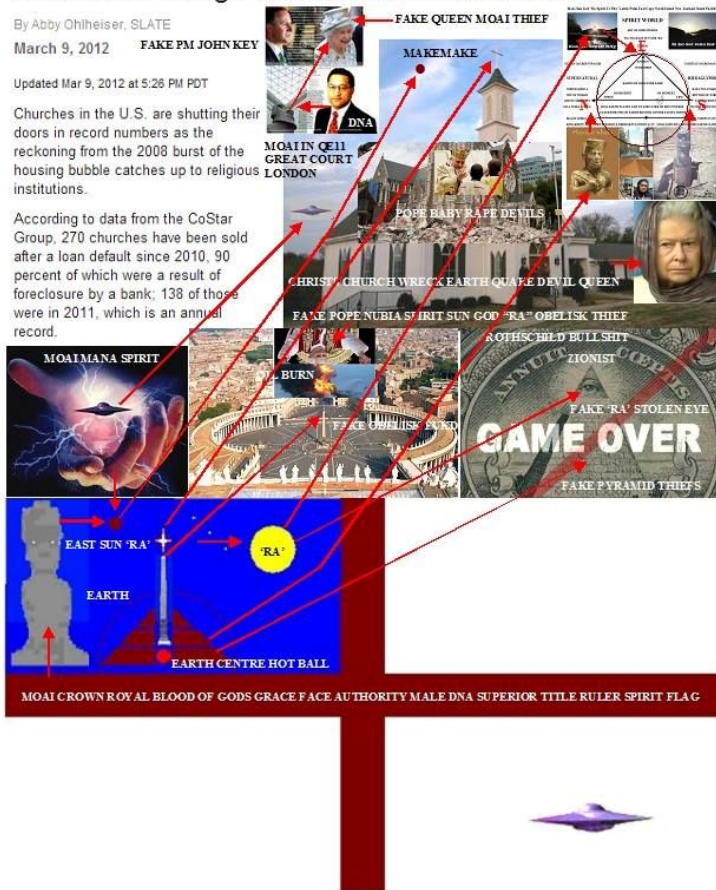

HIS Excellency the GOVERNOR is pleased to direct it to be notified, for general information, that a Despatch has recently been received from the Right Honorable the Secretary of State for the Colonies, conveying His Majesty's approbation of an arrangement made by this Government for complying with the wishes of the Chiefs of New Zealand to adopt a National Flag in their collective capacity, and also, of the Register of Vessels, built in that country, granted by the Chiefs and certified by the British Resident, being considered as valid instruments, and respected as such in the intercourse which those Vessels may hold with the British Possessions.

The following is a description of the Flag which has been adopted:—

A Red St. George's Cross on a White ground.
 In the first quarter, a Red St. George's Cross on a Blue ground, pierced with four white stars.

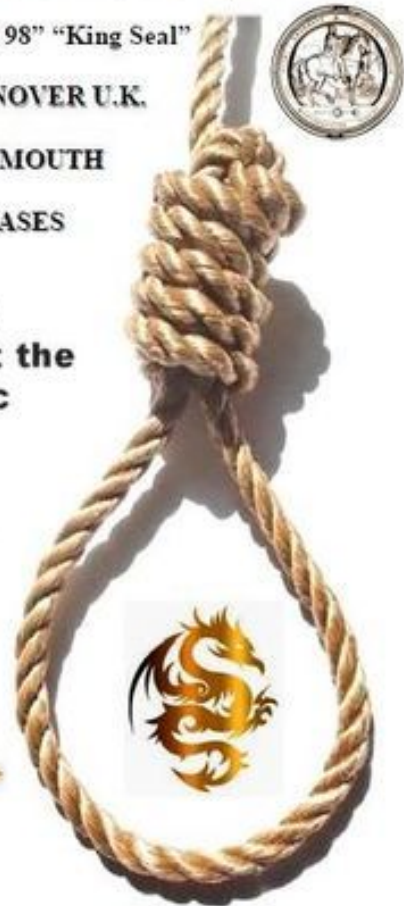

Section 5b in the original Act excluded domestic transactions and citizens of the US. § "Constitution of no Authority" by

Lysander Schooner. There is an unlimited grant of power HJR 192, (June 5, 1933), The Emergency Banking Act, which was codified into Title 31, section 5118 (2)(d). It is hereby declared to be against public policy for any contract or obligation to contain a clause which purports to give the obligee the right to demand payment in any kind of specific coin or currency of the US. In 1977, it was amended to allow gold and silver coins, but they are still not legal tender.

They are still not using money as legal tender. FRN are not money; they are private bills of credit aka bills of exchange. Under the UNCOTIL United Nations Commission On Trade and International Law, they superseded Article 3 of the UCC in December 5, 1988 in New York City. It is no good anymore under this convention. They have an International UCC and it tells you how to do these bills of exchange. There are 96 articles in this convention, and it tells you how to do the International Bill of Exchange. International Bill of Exchange Bank checks are International bills of exchange.

The United Nations Treaty is the Supreme Law of the Land, not the Constitution. 72 judges and commissioners, called the National Conference of Commissioners, put the UCC together in 1940. They did it from the NIL196 Negotiable Instruments Law 196, which comes from the **English Bill of Exchange Act of 1691 and 1692**.

Bill of Rights 1689,

The **Bill of Rights 1689**, also known as the **Bill of Rights 1688**,[\[nb 2\]](#) is a landmark [Act](#) in the [constitutional law](#) of [England](#) that sets out certain basic [civil rights](#) and clarifies who would be next to inherit [the Crown](#). It received the

[Royal Assent](#) on 16 December 1689 and is a restatement in [statutory form](#) of the [Declaration of Right](#) presented by the [Convention Parliament](#) to [William III](#) and [Mary II](#) in February 1689, inviting them to become joint sovereigns of England. The Bill of Rights lays down limits on the powers of the [monarch](#) and

sets out the rights of Parliament, including the requirement for regular parliaments, free elections, and [freedom of speech](#) in Parliament.^[3] It sets out certain rights of individuals including the prohibition of [cruel and unusual punishment](#) and confirmed that "[Protestants](#) may have arms for their defence

suitable to their conditions and as allowed by law". It also includes no right of taxation without Parliament's agreement. Furthermore, the Bill of Rights described and condemned several misdeeds of [James II](#) of England.^[4]

Provisions of the Act

The Declaration of Right was enacted in an Act of Parliament, the Bill of Rights 1689, which received the [Royal Assent](#) in December 1689.^[19] The Act asserted "certain ancient rights and liberties" by declaring that:^[20]

- **the pretended power of suspending the laws** and dispensing with [\[nb 3\]](#) laws by regal authority without consent of Parliament **is illegal**;
- the [commission for ecclesiastical causes](#) is illegal;
- levying taxes without grant of Parliament is illegal;
- it is the right of the subjects to [petition](#) the king, and prosecutions for such petitioning are illegal;
- keeping a [standing army](#) in time of peace, unless it be with consent of Parliament, is against law;
- Protestants may have [arms for their defence](#) suitable to their conditions and as allowed by law;
- election of members of Parliament ought to be free;
- the [freedom of speech](#) and debates or proceedings in Parliament ought not to be [impeached or questioned](#) in any court or place out of Parliament;
- [excessive bail](#) ought not to be required, nor excessive fines imposed, nor [cruel and unusual punishments](#) inflicted;
- jurors in trials for high treason ought to be freeholders;
- promises of fines and forfeitures before conviction are illegal and void;
- for redress of all grievances, and for the amending, strengthening and preserving of the laws, Parliaments ought to be held frequently.

The Act declared James's flight from England following the [Glorious Revolution](#) to be an [abdication](#) of the throne. It listed twelve of James's

policies by which James designed to "endeavour to subvert and extirpate the protestant religion, and the laws and liberties of this kingdom".^[21] These were:^[22]

- by assuming and exercising a power of dispensing with and suspending of laws and the execution of laws without consent of Parliament;
- by prosecuting the [Seven Bishops](#); by establishing the court of commissioners for ecclesiastical causes;
- by levying taxes for the use of the Crown by pretence of prerogative as if the same was granted by Parliament;
- by raising and keeping a standing army within this kingdom in time of peace without consent of Parliament;
- by causing Protestants to be disarmed at the same time when papists were both armed and employed contrary to law;
- by violating the freedom of election of members to serve in Parliament;
- by prosecutions in the Court of King's Bench for matters and causes cognizable only in Parliament, and by divers (diverse) other arbitrary and illegal courses;
- by employing unqualified persons on juries in trials, and jurors in trials for high treason which were not freeholders;
- by imposing excessive bail on persons committed in criminal cases against the laws made for the liberty of the subjects;
- by imposing excessive fines and illegal and cruel punishments;
- by making several grants and promises made of fines and forfeitures before any conviction or judgment against the persons upon whom the same were to be levied;
- all which are utterly and directly contrary to the known laws and statutes and freedom of this realm.

In a prelude to the Act of Settlement to come twelve years later, the Bill of Rights barred [Roman Catholics](#) from the throne of England as "it hath been found by experience that it is inconsistent with the safety and welfare of this Protestant kingdom to be governed by a papist prince"; thus [William III](#) and [Mary II](#) were named as the successors of James II and that the throne would pass from them first to Mary's heirs, then to her sister, [Princess Anne of Denmark](#) and her heirs (and, thereafter, to any heirs of William by a later marriage).

King Charles I Execution for Treason

Trial and conviction

After his defeat by Parliament in the Civil Wars, Charles I was imprisoned. On 20 January 1649 the High Court of Justice at Westminster Hall put him on trial for treason.

Putting a king on trial was a contentious issue. When it came to the trial, those who were against it were turned away or arrested. The remaining parliament was known as the 'rump' parliament.

The King refused to cooperate. He did not enter a plea or recognise the legitimacy of the court. Yet just seven days later, the judges returned a guilty verdict and passed the sentence of execution:

This Court doth adjudge that he the said Charles Stuart, as a Tyrant, Traitor, Murderer and Public Enemy to the good people of this Nation, [and] shall be put to death, by the severing of his head from his body'.

For the next three days Charles was kept under house arrest at St James's Palace. 59 signatures were collected for his death warrant. Politicians pushed through legislation to prevent his son, Charles (later Charles II), from succeeding him. He said goodbye to his two youngest children, Elizabeth and

Henry. The Queen, Henrietta Maria, and his two eldest sons were living in exile on the Continent. He took Holy Communion given by William Juxon, Bishop of London.

Treason Act 1695

King William III

The **Treason Act 1695** (7 & 8 Will 3 c 3) is an [Act](#) of the [Parliament of England](#) which laid down rules of evidence and procedure in [high treason](#) trials. It was passed by the English Parliament but was extended to cover Scotland in 1708^[2] and Ireland in 1821.^[3] Some of it is still in force today.

defines treason as levying war against the United States or "in adhering to their Enemies, giving them Aid and Comfort," and requires the testimony of two witnesses to the same overt act or a confession in open court for conviction. Congress has, at times, passed statutes creating treason-like

offenses with different names (such as sedition in the 1798 Alien and Sedition Acts, or espionage and sabotage in the 1917 Espionage Act) that do not require the testimony of two witnesses and have a much broader definition than Article Three treason. For example, some well-known spies have been convicted of espionage rather than treason.

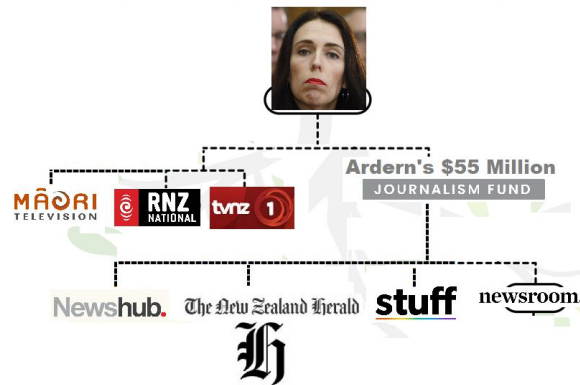

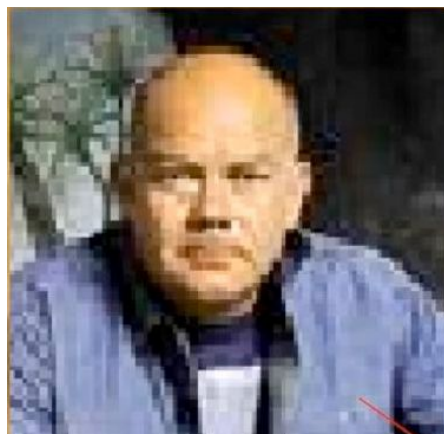

KINGS BENCH JURISDICTION POWER OVER INFERIOR COURTS

King's Bench jurisdiction or King's Bench power is the extraordinary jurisdiction of an individual state's highest court over its inferior courts. In the United States, the states of Pennsylvania, Virginia, Florida, New Mexico, New York, Oklahoma and Wisconsin^[1] use the term to describe the extraordinary jurisdiction of their highest court, called the Court of Appeals in New York or the Supreme Court in the other states, over the courts below it. King's Bench jurisdiction includes the power to vacate the judgments of inferior courts when acting in extraordinary circumstances, for example, where the importance of an issue to public well-being or the expediency with which action must be

taken in the interest of justice requires superseding normal judicial or appellate procedures. Federal courts in the United States possess the power to issue similar extraordinary writs under the All Writs Act. The term originates from the English Court of King's Bench.

Troubles and public feuds involved the supreme court in the early 1990s,^[6] specifically including Justice [Rolf Larsen](#), who was criminally convicted and impeached by the house, then subsequently convicted and removed from office by the state senate.^[7] The public image of Larsen illustrated the need

for court reform. The upheaval surrounding Justice Larsen's time on the bench served as a catalyst for a change in the state judicial discipline system.^[7] Pennsylvanians for Modern Courts credits the public turmoil he caused with leading to the overwhelming passage of a constitutional amendment that strengthened the way judges are disciplined for misconduct.^[7] In 1993, Pennsylvania voters amended the state constitution.

The change created a new system for the oversight of judges through a state Judicial Conduct Board, which independently investigates misconduct complaints, and a Court of Judicial Discipline, which independently determines a Pennsylvania judge's innocence or guilt.^[3] The supreme court, nevertheless, retains ultimate power over the Commonwealth's judicial system and judges.

For an example of the exercise of King's Bench jurisdiction, see the Pennsylvania ["kids for cash" scandal](#). In 2020 the King's Bench jurisdiction was exercised three times; this was a rare instance of the jurisdiction being exercised multiple times in one year:

In April 2020, the Pennsylvania Supreme Court exercised its King's Bench prerogative to take up *Friends of Danny DeVito v. Wolf*, regarding the Governor's executive order which forced businesses and a political campaign office to close due to the [COVID-19 pandemic](#).

In June 2020, the Pennsylvania Supreme Court exercised its King's Bench prerogative to take up *Scarnati v. Wolf*, regarding the separation of powers

between the Legislature and the Executive Branch to determine whether Title 35 of the PA code as written allows the legislature to force an end to Emergency Decrees made by the Governor.

In October 2020, the King's Bench power was invoked in ruling that ballots in an election cannot be discarded due to any subjective person deeming there to be a signature mismatch.[\[8\]](#)

Writs and warrants – information about execution of the writ or warrant 83.8

(1) If the creditor or debtor serves notice on the enforcement agent or enforcement officer requiring reasonable information about the execution of a writ or warrant, the enforcement agent or enforcement officer must send such information to the creditor or debtor within 7 days of service of the notice.

(2) If the enforcement agent or enforcement officer fails to comply with the notice, the party who served the notice may apply to the court for an order directing the enforcement agent or enforcement officer to comply with the notice.

Warrants of control – bankruptcy or winding up of debtor 83.20

(1) This rule applies where the enforcement agent responsible for the execution of a warrant of control is required by any provision of the Insolvency Act 1986¹¹ or any other enactment relating to insolvency to retain the proceeds of sale of goods sold under the warrant or money paid in order to avoid a sale.

(2) The enforcement agent will, as soon as practicable after the sale or the receipt of the money, send notice to the creditor and the court.

(3) Where the enforcement agent responsible for the execution of a warrant—

(a) receives notice that—

(i) a bankruptcy order has been made against the debtor; or

(ii) if the debtor is a company—

(aa) a provisional liquidator has been appointed; or

(bb) an order has been made or a resolution passed for the winding up of the company;

(b) withdraws from possession of goods seized; or

(c) pays over to—

(i) the official receiver or trustee in bankruptcy; or

(ii) if the debtor is a company, the liquidator,

the proceeds of sale of goods sold under the warrant or money paid in order to avoid a sale or seized or received in part satisfaction of the warrant,

the enforcement agent must send notice to the creditor and the court.

83.19

(1) This rule applies where the creditor makes a request for a certificate of judgment under rule 40.14A(1) for the purpose of enforcing the judgment or order in the High Court—

(a) by execution against goods; or

(b) where the judgment or order to be enforced is an order for possession of land made in a possession claim against trespassers.

(2) The grant of a certificate by the court will take effect as an order to transfer the proceedings to the High Court and the transfer will have effect on the grant of that certificate.

(3) On the transfer of proceedings in accordance with paragraph (2), the County Court will—

(a) give notice to the debtor or the person against whom the possession order was made that the proceedings have been transferred; and

(b) make an entry of the fact of transfer in the court records.

(4) In a case where a request for a certificate of judgment is made under rule 40.14A(1) for the purpose of enforcing a judgment or order in the High Court and any of the following proceedings are pending, the request for the certificate will not be dealt with until those proceedings are determined—

(a) an application for a variation in the date or rate of payment of money due under a judgment or order;

(b) an application to set aside or vary the judgment;

(c) a request for an administration order; or

(d) an application for a stay of execution under section 88 of the County Courts Act 1984.

Warrants of possession

83.26

(1) A judgment or order for the recovery of land will be enforceable by warrant of possession.

(2) An application for a warrant of possession—

(a) may be made without notice; and

(b) must be made to—

(i) the County Court hearing centre where the judgment or order which it is sought to enforce was made; or

(ii) the County Court hearing centre to which the proceedings have since been transferred.

(3) The court may, on an application by a debtor who wishes to oppose an application for a warrant of possession, transfer it to the County Court hearing centre serving the address where the debtor resides or carries on business, or to another court.

(4) Without prejudice to paragraph (7), the person applying for a warrant of possession must file a certificate that the land which is subject of the judgment or order has not been vacated.

(5) When applying for a warrant of possession of a dwelling-house subject to a mortgage, the claimant must certify that notice has been given in accordance with the Dwelling Houses (Execution of Possession Orders by Mortgagees) Regulations 201013.

(6) Where a warrant of possession is issued, the creditor will be entitled, by the same or a separate warrant, to execution against the debtor's goods for any money payable under the judgment or order which is to be enforced by the warrant of possession.

(7) In a case to which paragraph (6) applies or where an order for possession has been suspended on terms as to payment of a sum of money by instalments, the creditor must in the request certify—

(a) the amount of money remaining due under the judgment or order; and

(b) that the whole or part of any instalment due remains unpaid.

A warrant of restitution may be issued, with the permission of the court, in aid of any warrant of possession.

(9) An application for permission under paragraph. It may be made without notice being served on any other party and must be supported by evidence of—

(a) wrongful re-entry into possession following the execution of the warrant of possession; and

(b) such further facts as would, in the High Court, enable the creditor to have a writ of restitution issued.

(10) A warrant of possession to enforce an order for possession in a possession claim against a trespasser under Part 55 ('a warrant of possession against a trespasser') may be issued at any time after the date on which possession is ordered to be given.

(11) No warrant of possession against a trespasser may be issued after the expiry of 3 months from the date of the order without the permission of the court.

(12) Unless the court otherwise directs, an application for permission under paragraph (11) may be made without notice to any other party.

A subordinate account would be opened for the registration of deeds of assignment of the judgment debt, with its attendant charge upon the debtor's land; and on payment of the debt the estate would be discharged from it by a process similar to that above explained with reference to the discharge of a mortgage. The derivative property symbolized by a certificate of judgment would be available for many purposes, especially after the registration of the judgment had been acquiesced in for a time.

We may here take occasion to explain the principles on which claims would be admitted to the register. Any written instrument purporting to be signed by the registered proprietor, and to be attested, would be admitted without proof to registration against the properties mentioned in it specifically by numbers; and a judgment or order of any of the superior courts would be entered at the creditor's peril against properties standing in any name identical with that of the judgment debtor. Whether it would be desirable to allow the judgment creditor to enter his claim at his peril against properties not so standing, would be a point for consideration.

Notice (on a printed form) would be sent might be commenced by a writ in the following form:—

Victoria, &c. To the Sheriffs of London, Greeting.—We command you that you summon Peter Jones, of No. 27 Cheapside, in the city of London, Draper, to appear in our Court of Common Pleas, at Westminster, within eight days after he shall have been so summoned, at the suit of David Smith, to show cause, if he can, why the registration of a certain judgment entered by the said Peter Jones against the properties numbered from 24 to 48, both inclusive, in the Parish of Aylesbury, in the county of Buckingham, should not be discharged with damages and costs. And we command you that you return to our said Court what you shall have done in the premises immediately after the execution hereof.—Witness Sir Nicholas Conyngham Tindal, Knight, at Westminster, the twenty-fifth day of July, 1866.

Nothing need be said on the subject of bankruptcy and insolvency except that any certificates belonging to the bankrupt or insolvent would be seized by the assignees, and sold for the benefit of the creditors.

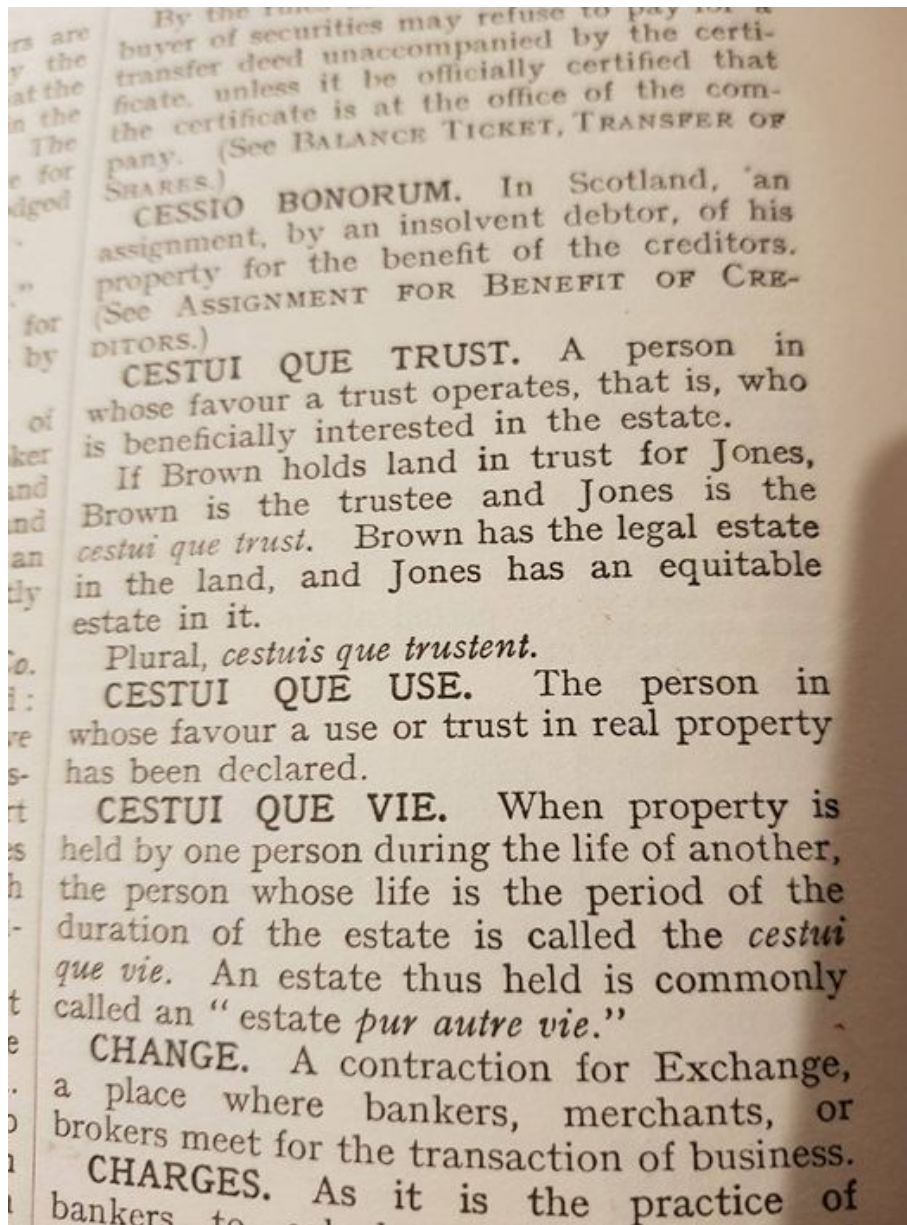

1666 CHAPTER 11 18 and 19 Cha 2

An Act for Redresse of Inconveniencies by want of Proove of the Deceases of Persons beyond the Seas or absenting themselves, upon whose Lives Estates doe depend.

X1Recital that Cestui que vies have gone beyond Sea, and that Reversioners cannot find out whether they are alive or dead.

Whereas diverse Lords of Mannours and others have granted Estates by Lease for one or more life or lives, or else for yeares determinable upon one or more life or lives And it hath often happened that such person or persons for whose life or lives such Estates have beene granted have gone beyond the Seas or soe absented themselves for many yeares that the Lessors and Reversioners cannot finde out whether such person or persons be alive or dead by reason whereof such Lessors and Reversioners have beene held out of possession of their Tenements for many yeares after all the lives upon which such Estates depend are dead in regard that the Lessors and Reversioners when they have brought Actions for the recovery of their Tenements have beene putt upon it to prove the death of their Tennants when it is almost impossible for them to discover the same, For remedy of which mischeife soe frequently happening to such Lessors or Reversioners.

[I.]Cestui que vie remaining beyond Sea for Seven Years together and no Proof of their Lives, Judge in Action to direct a Verdict as though Cestui que vie were dead.

If such person or persons for whose life or lives such Estates have beene or shall be granted as aforesaid shall remaine beyond the Seas or elsewhere absent themselves in this Realme by the space of seaven yeares together and noe sufficient and evident prooffe be made of the lives of such person or persons respectively in any Action commenced for recovery of such Tenements by the Lessors or Reversioners in every such case the person or persons upon whose life or lives such Estate depended shall be accounted as naturally dead, And in every Action brought for the recovery of the said Tenements by the Lessors or Reversioners their Heires or Assignes, the Judges before whom such Action shall be brought shall direct the Jury to give their Verdict as if the person soe remaining beyond the Seas or otherwise absenting himselfe were dead.

IVIf the supposed dead Man prove to be alive, then the Title is revested. Action for mean Profits with Interest.

hold and enjoy the said Lands or Tenements in his or their former Estate for and dureing the Life or Lives or soe long terme as the said person or persons upon whose Life or Lives the said Estate or Estates depend shall be liveing, and alsoe shall upon Action or Actions to be brought by him or them against the Lessors Reversioners or Tennants in possession or other persons respectively which since the time of the said Eviction received the Proffitts of the said Lands or Tenements recover for damages the full Proffitts of the said Lands or Tenements respectively with lawfull Interest for and from the time that he or they were outed of the said Lands or Tenements, and kepte or held out of the same by the said Lessors Reversioners Tennants or other persons who after the said Eviction received the Proffitts of the said Lands or Tenements or any of them respectively as well in the case when the said person or persons upon whose Life or Lives such Estate or Estates did depend are or shall be dead at the time of bringing of the said Action or Actions as if the said person or persons where then liveing.]

More Dumb Cluck Stuff -- Which "United States" Was That?

It is extremely important to know which "United States" you are talking about at any given time, and I can show you why with a salutary example. Read this statement, which is absolutely true so far as it goes, except that it doesn't identify which United States it is referring to:

From the United States Congressional Record, March 17, 1993: Vol. 33, page H-1303:

"It is an established fact that the United States Federal Government was dissolved by the Emergency Banking Act, March 9, 1933, 48 Stat. 1, Public Law 89-719; declared by President Roosevelt, being bankrupt and insolvent. H.J.R. 192, 73rd Congress m session June 5, 1933 - Joint Resolution To Suspend The Gold Standard and Abrogate The Gold Clause dissolved the Sovereign Authority of the United States and the official capacities of all United States Governmental Offices, Officers, and Departments."

Scary stuff, right? It looks like our government went down the tubes many years ago. It looks like we are beggars. It looks like the creditors --banks for the most part-- own everything in sight. So it appears.

It appears that way because you don't know two very important things: (1) Which "United States" are they talking about? and (2) What kinds of entities are eligible for bankruptcy protection?

There are four (4) principle versions of "United States".

There is The United States, which is the name of the Union of States controlling our national soil jurisdiction. This is the actual nation-states we are talking about, gathered together in a Union to be able to act together in concert for their mutual benefit. Each member state is a sovereign entity, while the Union doing business as The United States is an unincorporated mutually affiliated business structure -- a Union.

There is also the for-now defunct Federal Republic, which was intended to be our primary Federal Subcontractor, but which has been out of service since 1860 pending reconstruction--- and which did business as "the" United States from 1787 to 1860. The members of the Federal Republic were unincorporated American businesses operating as States-of-States, like The State of Florida and The State of North Carolina, which have been moth-balled as State Trusts since the 1860's

There is the Territorial "United States", the British Territorial version that operates as an incorporated entity doing business under various names, such as "the" United States of America, Incorporated, and has 57 "States" that include incorporated Territorial States-of-States and United States Possessions and Insular States like Guam. These "States" exist primarily on paper and are the precursors of actual States of the Union as required by the Northwest Ordinance.

Finally, there is the Municipal "United States" --- the Papist formerly Holy Roman Empire version, which operates as an incorporated entity doing business under various names, and which also claims to have 57 "states" that include Municipal STATES-OF-STATES, US POSSESSIONS, and INSULAR

STATES like GUAM. These STATES also exist on paper as incorporated entities, including US CORPORATIONS.

So, which "United States" went bankrupt in 1933?

We know it wasn't the Union, because the Union is unincorporated and not eligible for bankruptcy protection.

We know it wasn't the Federal Republic because it wasn't doing business at the time and like the Union, was never incorporated, and therefore never eligible for bankruptcy protection.

Of the two remaining options that were incorporated and were eligible for bankruptcy protection the "United States" that went bankrupt in 1933 had to be one of the two incorporated versions of "United States" -- the so-called Territorial United States or the Municipal United States.

Which one was it?

It could only be the Territorial version, doing business as "the" United States of America, Incorporated. We know this from many other public and private records, but the fact that it appeared in the Federal Record, was the subject of action by the U.S. Congress, resulted in "Public Laws" like 73-10, involved removal of the Gold Standard, and resulted in pledges by the Territorial State-of-State Governors at the March 6, 1933 Conference of Governors tells us without a doubt that it was the British Territorial Government, Incorporated, that went bankrupt.

We are able to deduce this easily, because we know what the principal entities called "United States" are or were, we know which ones operate as incorporated entities, and that tells us which were eligible for bankruptcy protection.

From there, we can deduce which entity was involved from the references and nature of the actions and where the public records were posted.

Contrary to what might have been your initial impression, our country and our government did not go bankrupt. Ever.

What went bankrupt was a British Territorial Corporation in the business of providing governmental services under contract, and like any insolvent corporation, it's offices were vacated in receivership and its franchises were held accountable for the parent corporation's debts.

It's only relationship to us was as a limited service provider under contract.

Except that this particular Federal Subcontractor was unable to pay its debts and unable to perform its functions, nothing much happened. A new Territorial corporation was quickly organized, took on a similar name, assumed a Successor to Contract position, and that was that.

Of course, the franchises doing business as, for example, the State of Ohio, were hard-pressed to pay off the debts of the erstwhile parent corporation, and the Territorial "citizenry" of Ohio was equally hard-pressed --- but in fact, none of this had anything to do with the millions of Americans who were subsequently "presumed" to be Territorial U.S. Citizens and coerced to pay debts they didn't owe.

Read that -- this 1933 bankruptcy had nothing to do with our version of "United States".

Penalties The three main Fraud Act offences are punishable by up to ten years' imprisonment and/or a fine.

Corporate offenders convicted of financial crime will be sentenced according to the ten-step process set out in the UK Sentencing Council's Definitive Guideline for Fraud, Bribery and Money Laundering Offences, which came into force on 1 October 2014 and was updated on 16 May 2016 (see www.sentencingcouncil.org.uk/offences/magistrates-court/item/corporate-offenders-fraud-bribery-and-money-laundering).

A person convicted of a Fraud Act offence may become the subject of a confiscation order under the Proceeds of Crime Act 2002 (POCA) if they benefitted from the offence.

For the regulatory sanctions available to the FCA, see [Question 6](#).

Right to Bail In criminal proceedings there is a rebuttable presumption in favor of bail. (Prior to the commencement of criminal proceedings, at the pre-charge stage, there is a presumption in favor of releasing a suspect without bail). The grounds for withholding bail are set out in the Bail Act 1976.

As with pre-charge bail, such conditions can be attached to the bail as are considered necessary for the person's own protection or for the purpose of ensuring that the person either:

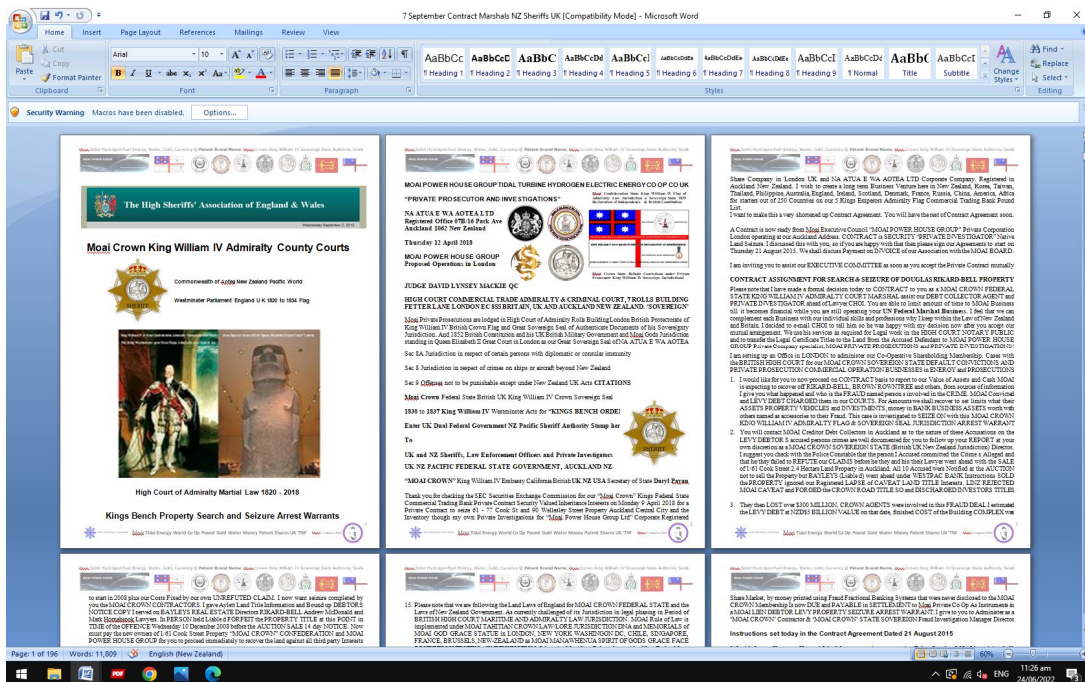
