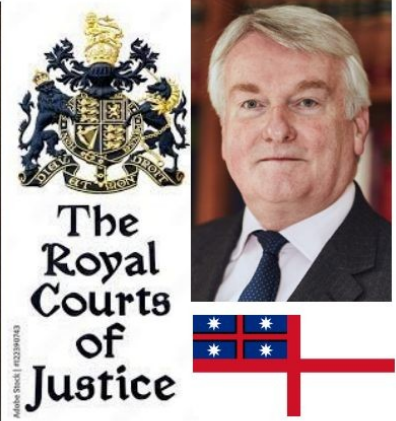
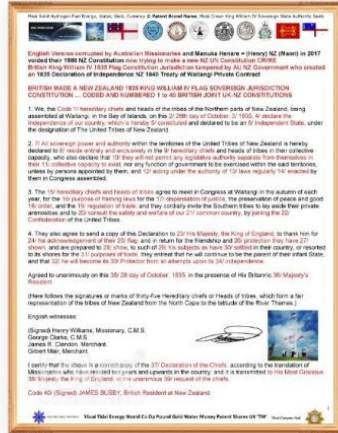

## Arrest

### 315 Arrest without warrant

(4) Where under any enactment other than this Act any officer or person, not being a constable, has power to arrest any other person without warrant, any constable may exercise that power in the same cases and in the same manner as that officer or person. (As Enforced by Moai Crown Court Native Judge Official Assignee and or Private Investigator Aylett Investigations Limits Auckland NZ)

### 316 Duty of persons arresting

(1)

It is the duty of every one arresting any other person to inform the person he or she is arresting, at the time of the arrest, of the act or omission for which the person is being arrested, unless it is impracticable to do so, or unless the reason for the arrest is obvious in the circumstances. The act or omission need not be stated in technical or precise language, and may be stated in any words sufficient to give that person notice of the true reason for his or her arrest.

(2)

It is the duty of every one who arrests any other person pursuant to any process or warrant—

(a)

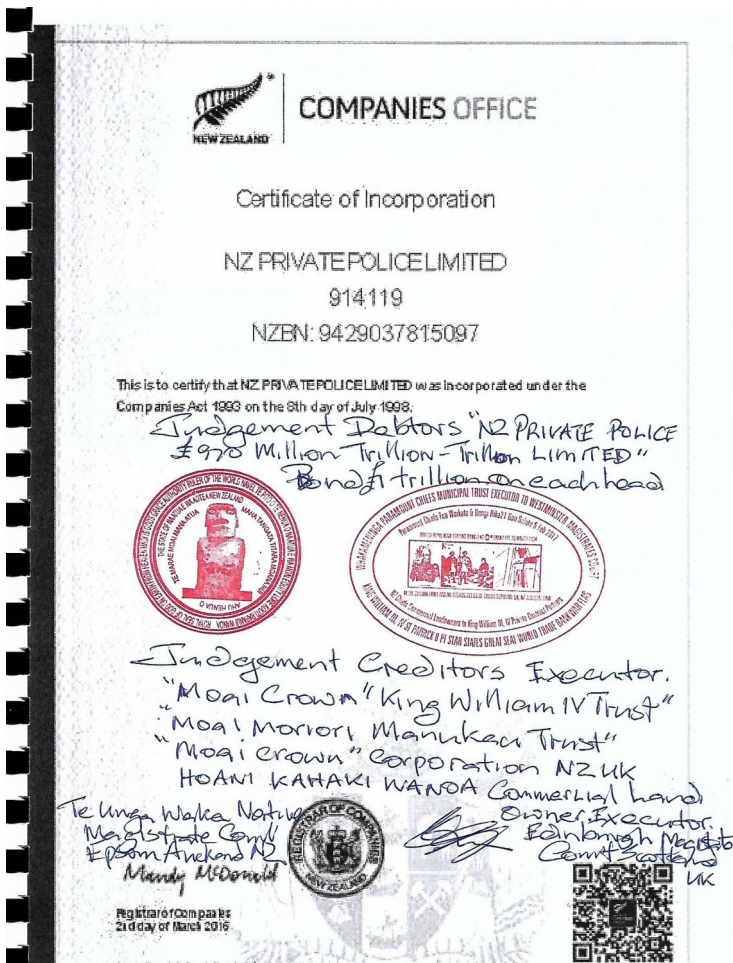
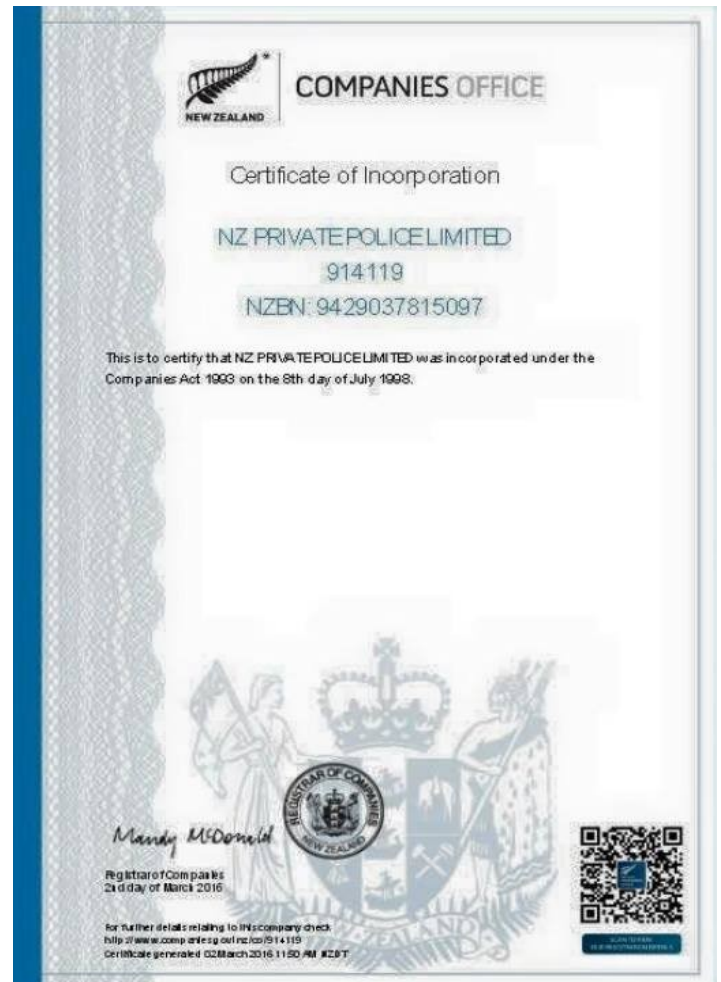

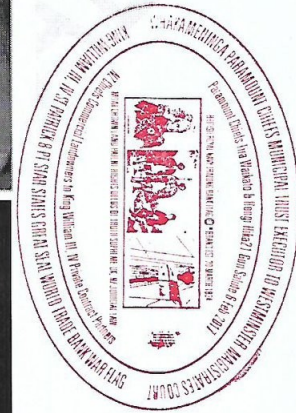

Constitution Act 1852

THE NEW ZEALAND CONSTITUTION ACT.

ENGLISH VERSION.

"The New Zealand Constitution Act, 1852."— 15 and 16 Victoria, Cap. 72, Sec. 71.

Her Majesty may cause Laws of Aboriginal Native Inhabitants to be maintained.

Passed 80th of June, 1852.

SECTION 71.—And Whereas it may be expedient that the Laws, Customs, and Usages of the Aboriginal or Native Inhabitants of New Zealand, so far as they are not repugnant to the general principles of Humanity, should for the present be maintained for the Government of themselves, in all their relations to and dealings with each other, and that particular districts should be set apart within which Laws, Customs, or Usages should be so observed. It should be lawful for Her Majesty, by any Letters Patent to be issued under the Great Seal of the United Kingdom from time to time to make Provisions for the purposes aforesaid, any repugnancy of any such Native's Laws, Customs, or Usages, to the Law of England or to in any part thereof, in any wise notwithstanding.

'An Act to grant a representative constitution to the colony of New Zealand' was passed by the British Parliament in 1852. The act set up six provinces to be governed by elected councils. Section 7 stated that eligible voters were males aged 21 or over who owned freehold land worth at least £50, or leased land for £10 or more a year. This act therefore did not exclude Māori males from voting, and some Māori voted in the first elections held after it was passed. However, Māori traditionally owned land on a tribal basis, and only a small minority owned or leased freehold land in the 1850s. Therefore, non-Māori voters far outnumbered Māori.

This extract from the act was published in several successive issues of the Taranaki Herald from 8 December 1852. Section 71 was never implemented.

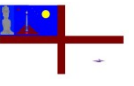

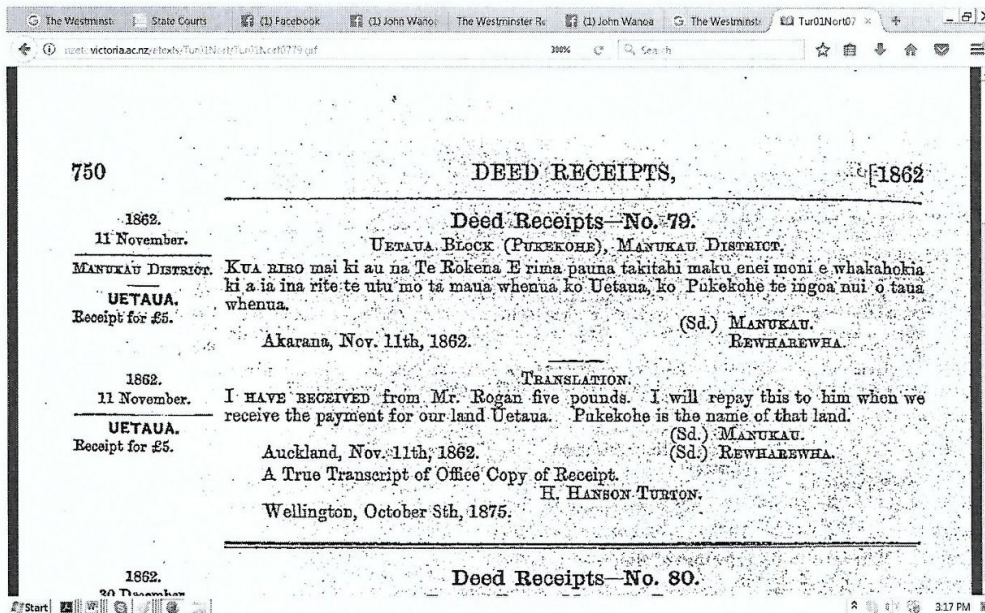
Ngāpuhi controlled the Bay of Islands, the first point of contact for most Europeans visiting New Zealand in the early 19th century. Hongi Hika protected early missionaries and European seamen and settlers, arguing the benefits of trade. He befriended Thomas Kendall—one of three lay preachers sent by the Church Missionary Society to establish a Christian foothold in New Zealand.

In 1814 Hongi Hika and his nephew Ruatara, the then-leader of the Ngāpuhi, visited Sydney, Australia, with Kendall and met the local head of the Church Missionary Society Samuel Marsden. Ruatara and Hongi Hika invited Marsden to establish the first Anglican mission to New Zealand in Ngāpuhi territory.<sup>[4]</sup> Ruatara died the following year, leaving Hongi Hika as protector of the mission. In 1817 Hongi led a war party to Thames where he attacked the Ngati Maru stronghold of Te Totara, killing 60 and taking 2000 prisoners.<sup>[5]</sup>

On 4 July 1819 he granted 13,000 acres of land at Kerikeri to the Church Missionary Society in return for 48 felling axes,<sup>[6]</sup> land which became known as the Society's Plains. He personally assisted the missionaries in developing a written form of the Māori language.

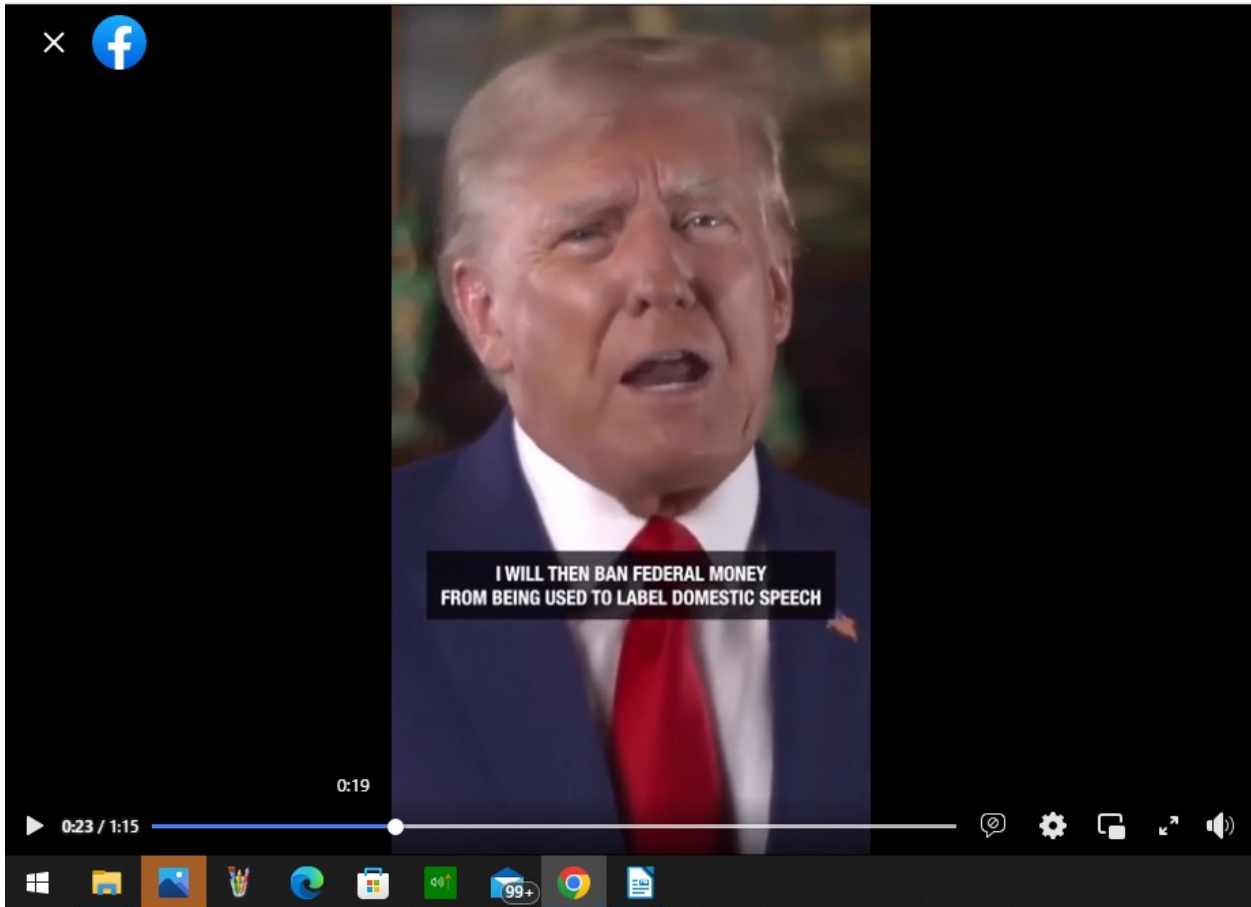
Hongi Hika never converted to Christianity. In later life, in exasperation with teachings of humility and non-violence, he described Christianity as "a religion fit only for slaves". He protected the Pakehā Māori Thomas Kendall when he effectively "went native", taking a Māori wife and participating in Māori religious ceremonies. Though Hongi Hika encouraged the first missions to New Zealand, virtually no Māori converted to Christianity for a decade; large scale conversion of northern Māori only occurred after his death.

While in Australia Hongi Hika studied European military and agricultural techniques and purchased muskets and ammunition. From 1818 he introduced European agricultural implements and the potato, using slave labour to produce crops for trade.

## Background

This is a Reserve Bank of New Zealand 1951 fifty pound note.

In New Zealand, paper money arrived with the Europeans. Prior to 1934, the six trading banks had produced the banknotes that were in common circulation. In 1924 the trading banks reached an agreement on a uniform design.

By the 1920s there was a general push to establish a central bank that would issue a single national currency. The decision was finally taken in 1930, and steps went ahead to set up the Reserve Bank in New Zealand with sole authority to issue New Zealand's currency.

Work to design new banknotes began in 1932. They were finally issued in August 1934, six months after the Reserve Bank started.





The first banknotes were introduced in 1934. The second series was issued in 1940. The design and colours for the £50 note were changed. A portrait of Captain James Cook replaced that of King Tawhiao.

### Māori banknotes

In 1886 the Māori King Tāwhiao established a bank, Te Peeke o Aotearoa, which was in business until around 1905. It was set up to provide banking and monetary services to Māori and was also an expression of Māori autonomy.

The bank produced banknotes, though none seem to have been officially issued. The few that survive are among the rarest notes in New Zealand. The surviving notes differ slightly and some have a truncated version of Tāwhiao's name – 'Tawhia' – in one corner.

"It is unequivocally New Zealand's first government-issued banknote," Garrett said.

"There's a big international following for banknotes like this.

"If you asked a hundred collectors there would be a hundred different reasons they collect things. But usually it's just as simple as they just like it."

The 10 shilling note has the serial number Z000001 showing it is the very first note off the press.

An inflation calculator estimates that ten shillings from 1934 would be worth \$11.81 today.

The American auction house Stack's Bowers Galleries starts the bidding on August 12. An opening bid will cost you US\$30,000 (\$41,500).

The auction states that the note can be traced back to the secretary of the treasury from 1929 to 1935 A.D. Park. He was presented the note by the Directors of the Reserve Bank when these notes were first issued in 1934.

"This is a highly significant item and arguably the most important banknote known to exist for all of New Zealand.

"These ten shilling notes feature a kiwi and a Maori chief and are quite rare. This would be a valuable note just for its condition alone. However, the serial number Z000001 moves the note into a category where it isn't just a rare collectible item, it is also a tangible piece of New Zealand's financial history."

Garrett said the note, which is in pristine condition, was sold after the original owner died around 30 years ago. This auction is the first time the note has been exposed to the international public.

"In the 1980s is when it first hit collector hands. It's just gotten to the point where it's ended up in the US.

New Zealand's banknote history

- From the 1800s until the early 1930s, British and Australian paper money was commonly used throughout New Zealand.
- As late as the 1920s there were six different Australian banks circulating currency throughout New Zealand and the banknotes weren't always interchangeable with each other.
- That problem, mixed with a growing population, made a new national currency an important priority.
- And in 1934 New Zealand's first banknotes were issued. Australia issued its national banknotes 21 years prior in 1913.

"We hope it's going to go back to New Zealand."

The Royal Numismatic Society of New Zealand president David Galt said that the Maori chief on the note is the second Maori king Tawhiao and the pictured North Island brown kiwi was based on a painting by a Dutch artist.

"Banknotes are designed with the intersection of art, commerce and history.

"It is significant as it is the first 10 shilling note that was actually issued.

"It's going for a lot more than you'd pay for a comparable bank note of an ordinary serial number."

Galt said the notes had been designed in a hurry and that particular style only lasted six years.

"It was a bit of an emergency design."

The featured Maori chief Tawhiao was born in 1825 to become king in 1860. He led a delegation to Queen Victoria in England to bring justice to the Treaty of Waitangi in 1884 but was denied an





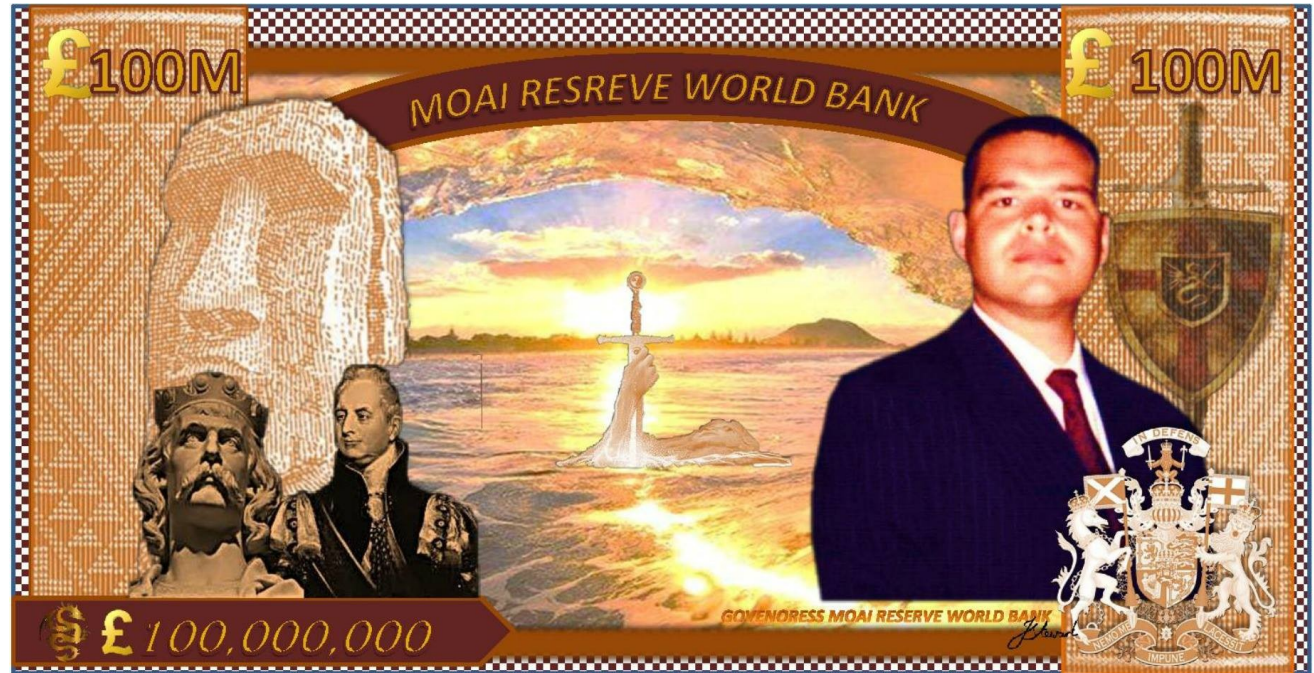
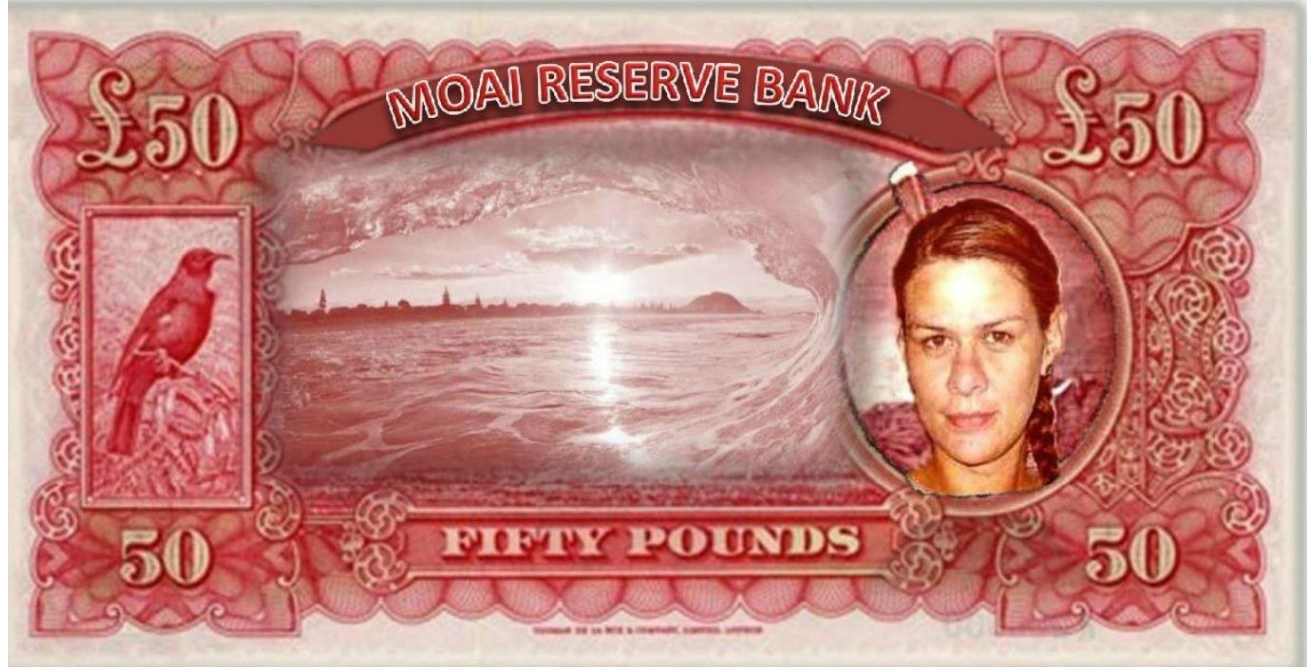

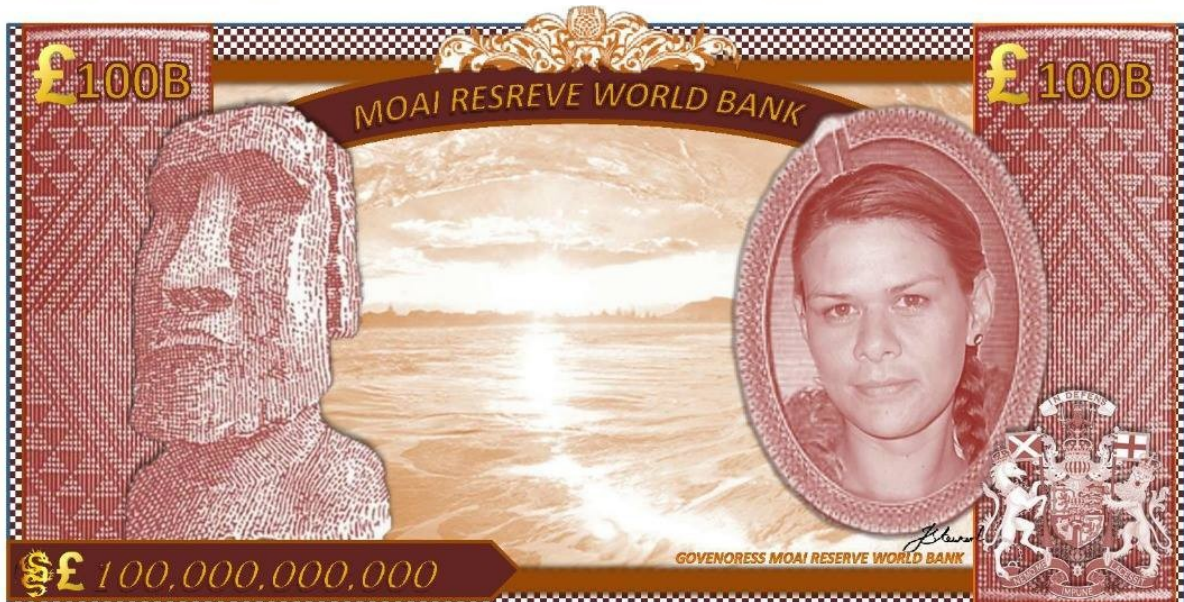

**Prime Minister Chris Hipkins and a contingent of senior ministers and staff have arrived at Waitangi.**

Around 50 Government officials were welcomed by the Iwi Chairs Forum this morning.

Raniera Kaio, of Te Runanga o Whaingaroa, who are the hosts for this year's forum, spoke first and acknowledged the passing of Titewhai Harawira.

Minister Peeni Henare responded, also acknowledging Harawira, saying the Government and the iwi leaders were united through that.

Henare also pointed out that in previous years, smaller government contingents had made the trip, but this year there was a large one. Co-governance, Three Waters and the Ngāpuhi Treaty settlement will be on the table for discussion.

Iwi chairman Jamie Tuuta told 1News he was concerned about the misinformation around the Three Waters. He said "the communications could've been better" on the reform, but that Māori were being used as a "political football" going into an election.

"Māori involvement has been used as a political football for those other political parties.

"That's the disappointing thing for the forum is this misinformation.

"One of the key messages we want to give to the prime minister and other ministers is that they need to stand up, they need to step up. And it's unacceptable — because again, the racist and biased attacks on Māori in 2023 are unacceptable," he said.



## Language around co-governance discussed - Hipkins

Speaking to media after the forum, the prime minister said discussion centred around how iwi chairs are working with the Government on the "bread and butter issues" of housing, education and health, and the language around co-governance.

Hipkins said "the breadth of our work programme as a Government" had contributed to issues communicating co-governance proposals.

"The more you're doing, the more confusing for people it can be" for those without detailed knowledge of the specific co-governance proposals, which he said vary depending on the context.

"Where there is a lack of clarity, that can lead to fear," a dynamic he said iwi chairs did not want surrounding co-governance.

"Politicians who use that fear or exploit that fear in order to gain political advantage really need to reflect on their own actions. That's something my government will never do."

The prime minister said both National and ACT were stoking uncertainty around co-governance for political gain.





Also asked whether New Zealand would consider removing the British monarchy from its bank notes as Australia [has done](#), he said he hasn't "ever thought of that". But he said there will always be opportunities to be more New Zealand in the future "as we become a more independent and proudly independent nation".
